We represent non-party Jill A. Dunn, Esq. We write to the Court to seek clarification of Text Only Orders entered by the Court on August 11 and 22, 2011.

On August 1, we filed an application for an Order to Show Cause seeking a stay pending appeal of the sanctions imposed by the Memorandum-Decision and Order of United States Magistrate Judge David R. Homer on July 20, 2011 (Dkt. Nos. 352-353). On the same day, we filed a Notice of Objections/Appeal from that July 20 Decision (Dkt. No 351). Plaintiff Securities and Exchange Commission opposed the application (Dkt. No. 362), and on August 11, the Court entered a Text Only Order stating that "any appeal should be directed to the Court of Appeals."

On August 19, the SEC sought clarification of the Court's August 11 Order (Dkt. No. 370); on August 22, the Court entered a Text Only Order, stating, "The Appeals of Magistrate Judge Decision (Dkt. Nos. 351, 355-357) are DENIED for this court lacks jurisdiction to consider any of the Notices of Objections/Appeal from Judge Homers July 20 Memorandum-Decision and Order for the reasons set forth in its August 11 Order and direct that any appeal from the July 20 Memorandum-Decision and order are to be filed with the Court of Appeals."

On September 15, 2011, we filed a Notice of Appeal to the Court of Appeals from Magistrate Judge Homer's Memorandum-Decision and Order (Dkt. No. 381).
