Dear Judge Sharpe:

I am writing in respect of the letters of Bonnie Golub, Esq. filed at Docket Nos. 861 and 872.

Ms. Golub did not confer with me with respect to her requests, and I can find no ruling by the Court as to her letter request at Docket No. 861 for an extension of time. Her letter filed yesterday afternoon at Docket No. 872 presumes that she will have additional time beyond the February 16, 2016 deadline to file a complete Objection to the Receiver's Plan. She proposes a date of Wednesday, February 24. If the Receiver is to adequately understand and respond to Ms. Golub's Objection, it should be the complete Objection, not a redacted version or incomplete version.

I will be traveling to London on February 24, 2016 on a long planned trip to visit my daughter and will be returning to the United States on the evening of March 3, 2016. Accordingly, since the Objection filed by Ms. Golub at Docket No. 862 is incomplete, the Receiver respectfully requests the Court to adjust the Briefing Schedule at Docket No. 851 to allow the Receiver until March 9, 2016 to file his Omnibus Reply to the Plan Objections.
